- Each member will receive a member card. b.
- All members accessing the Centre must scan their c. membership card upon entry to the Centre zone at every visit.

- All 'guest visitors' to Centre are required to present g. to Centre staff upon every visit
- Entry to the Centre may be refused as a result of h. unpaid or outstanding membership fees.
- Please advise us of any changes to your address and / or contact information.
- **GENERAL CONDITIONS OF ENTRY**

To assist us in maintaining a safe and comfortable environment for all members and staff, please abide by the following conditions. Failure to abide by these conditions may result in the suspension or termination of your membership.

- ENTRY a.
 - Entry will be refused or you may be requested to leave the Centre if:
 - i. You are using abusive or threatening language or behaving in a threatening way. You are under the influence of drugs or alcohol.
 - ii
 - iii. You must be a minimum age of 15 years to use Centre's GYM facilities.
- NON-SMOKING b.
 - Centre is a non-smoking facility.
- DRESS CODE c.
 - i. Fully enclosed, clean sports shoes must be worn during workouts for safety reasons.

USE OF SWIMMING POOL 7

- Member under "Swimming class packages" allowed to а. use the pool under swimming instructor coaching.
- b. Member with "Combo Package" only allowed to use the swimming pool in the event that there is not swimming class ongoing.
- There will be no lifeguard on duty, Centre will not be c. liable for any incident of drowning or injury during the usage of the swimming pool.
- Member required to wear swimming cap all the time d. during the usage of the swimming pool.

Proper swimming attire is required. e. SWIMMING CLASS

- Adverse weather & Safety Precautious a.
 - i. For outdoor swimming pool, due to any unforeseen circumstances, once a swimming lesson has commenced and has to be called off in the middle of a lesson, indoor training will be conducted in replacement of the usual practical lessons such as but not limited to if the weather is not suitable to continue
 - ii. There will be no compensation or make up lesson if the pool is close due to bad weather or facilities break down that is out of the academy's control.

However, the instructor will stand by to continue the lesson as soon as the pool is deemed safe for swimming. Lesson will be conduct as usual under drizzling rain condition.

- b. Attendance & Replacement
 - i. Replacement will be provided in strictly once in a month. If there are more than 1 absent, only one replacement credit will be given.
 - ii. Replacement shall be applied or informing the counter person in charge within 30 days before or after the actual absent day. If member fail to do so, replacement will be forfeited and no replacement shall be given.
 - Only 4 classes/lessons will be provided in a month. In case of 5th week, there will be no swimming lesson during that week.
- c. Examination and certification
 - i. Member is compulsory to take up all examination and certification arrange by the centre.

9. LOCKERS

- a. Lockers are available for use in the Centre
- b. Casual use lockers are available free of charge in the hallway of the Centre
- c. Casual lockers are limited to 12 hour use only
- d. Please look after your personal items. The Centre, its employees, or contractors, are not responsible for any loss of personal property.
- e. Please do not bring bags to the gym floor.

10. LOST PROPERTY

- a. We highly recommend that you use lockers for your belongings.
- b. Centre does not take responsibility for loss or damage of your belongings.

11. MEMBERSHIP

a. ENTITLEMENTS

Membership at Centre entitles you to:

12. CANCELLATION / TERMINATION

a. For monthly membership, Centre requires 1 month notice in a written request to terminate the membership to stop reoccurring charges. Advance fee will be used to pay for the last month membership fee.

13. Refund Policy
